"A Year of Celebrating Service" will offer three contests, each one awarding a \$1,000 U.S. Savings Bond as its prize. "Why I Believe in America" will conclude on May 31, 2009. Contests "How I Celebrate Freedom" and "What Inspires Me to Serve" will follow in the coming months.
